This month, we fondly remember and celebrate the life and contributions of Past President **Betty Hatch**. Here are a few words about her consistent leadership and dedication to AAUW at the state, local, and national levels. She will be missed!

Betty Haydn Purvis Hatch was a member of Alameda AAUW for 40 years. She attended school in Alameda and was a graduate of the University of California, Berkeley. She was a member of Phi Mu Fraternity and was still in touch with many of her sisters. She was a Physical Education teacher and a lifelong volunteer. She married Phillip L. Hatch, who served in the Army. They had two children -- Phyllis, of Santa Clara, and Clark, whose permanent home is in Del Rey Oaks with his wife, Dawn. Clark and Dawn are moving from Germany to Washington, D.C. because of his job. Their son, Connor, Betty's adored grandson, attends Cal Poly San Luis Obispo.

Betty passed away on April 18 in her sleep after spending the day in a boat rowing with friends of many years. PEO members had a memorial service for her on May 20th.

She was twice president of our Branch, 1981-1982 and 2005-2006, and, when living in Littleton, Colorado, where Phillip was transferred with Southern Pacific Railroad, she became actively involved as a member of the Littleton branch of AAUW. Fortunately for us, she returned to Alameda in 2004. Betty was always willing to help within our Branch, and served on many Committees. She was a Convention Delegate regularly and provided detailed reports about her experiences to the Branch. She was a Named Gift Honoree, Century Club member, Fundraising Chairwoman, Newsletter editor, Installation officer, EF supporter, Parliamentarian, and, in general, a leader in all areas.

She was equally involved in the California State Division and as Member Coordination Assistant. She ran the show when necessary, multi-tasking for successful fundraisers, including calculating costs, purchasing supplies, and supervising food preparation in the kitchen.

REDUCE YOUR TAXABLE INCOME BY HELPING AAUW

Under the new tax law, your charitable donations will not yield a tax benefit unless your total itemized deductions exceed \$12,200 for single people, \$24,400 for married couples filing jointly. As a result, you must donate considerably more to charity in 2019 to receive a tax benefit from your donation than in prior years. There is a simple solution, however, if you are over the age of 70-and-a-half years old and must take the Required Minimum Distribution (RMD) from IRA accounts. You can both do good and do well (tax-wise) if you donate to AAUW (and other charities) directly from the annual RMD from your IRA accounts. You or the person/entity managing your IRA accounts simply makes the donations to AAUW and other charities as part of the distribution. The donations come right off the top of the RMD, thereby reducing your taxable income by the amount of your charitable contribution(s).

Please discuss with your accountant or other tax advisor the benefits of making a donation to AAUW as part of your RMD. If you will itemize your deductions, you can still reduce your tax liability with a donation to AAUW. Either way, you help AAUW and reduce your taxes.

I will also be pursuing my Doctoral degree in Pharmaceutical Sciences at UCSF, starting in fall 2020. Throughout my gap year, I will continue to work in the industry in order to gain a deeper knowledge of the "pharma world" while giving back to my community and mentoring college students through my involvement with AAUW and UC Berkeley. After receiving my Ph.D., I plan to transfer my academic knowledge to the industrial level, at the same time continuing to help and mentor students to succeed in their college careers. Through organized workshops, I plan to provide disadvantaged and underrepresented college students with specialized training to help them pursue doctoral degrees and achieve their dream careers in STEM by overcoming any obstacles they may encounter. In my free time, I enjoy reading novels and poetry, watching soccer games, and doing yoga!

AAUW Work Smart Initiative

AAUW has established a goal of providing salary negotiation training to 100,000 women this year and 1,000,000 women by 2022 in order to help close the wage gap between men and women. AAUW has developed an **online training module** for individual women to learn salary negation skills. It is **available to all, not just members**.

To reach its goals, AAUW National is asking its members for their help in **making the online training tool available to as many working women as possible**. Museum Group will go to the Legion of Honor's exhibit, JAMES TISSOT, FASHION AND FAITH, on November 7.

James Tissot (1836-1902) was born in France. His family was in the textile business. James became interested in depicting fashion--costume, precise detail, and social satire. Tissot had the advantage of being able to use chemical advances in paints, which significantly impacted artists' choices, as more vibrant hues were available.

Tissot did not flee the Franco Prussian War (1870-1871) like Monet and Pissarro, but enlisted to fight like other artists, including Manet and Degas. Tissot documented the atrocities of his experiences as a sharpshooter in sketches, which he later made into prints.

After the war, he moved to London and entered another phase of painting, becoming a visual storyteller. Elie Roy said, "...a painting by Tissot will be enough for the archaeologists of the future to reconstruct our era." Tissot painted beautiful and complex portraits of his muse and wife, Kathleen Newton. When Kathleen died of tuberculosis at age 28, Tissot abandoned a mansion and gardens in a bohemian enclave and returned to Paris. He embarked on an ambitious campaign to reenter the French art world with a series of 15 large-scale paintings representing La Femme a Paris. He planned to accompany these prints with short stories written by famous contemporary artists.

During his research for one of these compositions, Tissot experienced a religious vision in Paris's Church of Saint-Sulpice. The last two decades of his life were spent creating sketches and watercolor illustrations for the Bible, which were made in tandem with three trips to the Holy Land. Tissot made a fortune from the sale of his Biblical illustrations. These illustrations inspired early filmmakers such as William Wilder, creator of the film Ben Hur.
